### **COURSE DURATION:**

## **PRE-COURSE TRAINING:**

The Course includes a text book "The Practice of Counselling and Clinical Supervision-Austrialian & International Applications (third edition)" edited by Nadine Pelling and Philip Armstrong and a training manual. It is mandatory to study the prescribed textbook provided as a course material and answer the assessment questions. It provides the participant with a broad theoretical understanding of the different settings and theories of Supervision. It is suggested that student allocates at least 5 days or the equivalent in hours to read the text and answer the questionnaire. The successful completion of the questionnaire is required before the trainee can move into the 3 Day workshop phase.
